Since 1957, the Occupational Therapy Department has been involved in helping people with disabilities become safe, skilled, and independent drivers. The Driver Rehabilitation and Training Program offers a variety of services that can be individualized to the client.

### Who Can Benefit?

People with age-related changes, amputation, arthritis, brain injury, cerebral palsy, chronic disabilities, dementia, diabetes, multiple sclerosis, polio, spina bifida, spinal cord injury, stroke, medically at-risk seniors, and others may benefit from this program.

### Requirement:

The Driver Rehabilitation and Training Program is a hospital-based program; therefore, those interested must provide a physician’s referral, medical history records, and health insurance information. A valid driver license or instruction permit is needed for any on-road evaluation and training.

### Staff:

Highly qualified staff includes registered/licensed occupational therapists, certified driver rehabilitation specialists, and driver rehabilitation driving instructors.

## **OCCUPATIONAL THERAPY DRIVER REHABILITATION PROGRAM**

### **Services Provided:**

- Group education sessions: Introduction to the Program, Getting a License/Permit, and Preparing for the Written and Road DMV Test
- Occupational Therapy clinical driving evaluation, with physical, mental, and visual-perceptual assessments
- Driving skills analysis and training using a computerized driving simulator
- On-road evaluation and training of driving potential in one of the program's modified vehicles
- Individualized driver training with adaptive driving equipment on the simulator or in the program vehicles
- Defensive driving instruction
- Refresher course for seniors or other medically at-risk drivers
- Resources for commercially-available driving equipment and modified vehicles
- Procedures for the DMV Driver Safety Office and preparation for the DMV licensing exam
- Information and counseling about client-centered driving needs, cessation of driving, or family interventions.
- Community mobility training and exploration of driving alternatives including passenger evaluation
- Referrals to other driving resources as appropriate
- Annual CarFit Events
